Our Impact

Over the last fiscal year, we awarded \$1.68 million to 75 organizations working on issues impacting West Marin and its people. Here are a few milestones we're proud to share.

Community Enrichment

Provided grants for community events and activities that enhance the lives, creativity, and cultural experience of people who live, work, and visit West Marin. A total of \$47,906 was awarded to 12 organizations working to strengthen the social fabric and cultural diversity of our region.

Nonprofit Effectiveness

Strengthened the capacity of West Marin leaders and nonprofit organizations to better deliver on their mission. Twenty grants totaling \$180,806 supported staff trainings and improved operations. Four grants totaling \$600,000 facilitated collaboration among 21 organizations to reduce service gaps for school children, Latine families, and low-income households.

Housing Action

Drew attention to substandard worker housing in West Marin and supported actions to ensure safe, affordable, and dignified housing for all. Funded local community land trusts, co-published a Housing Action Study, and launched the Housing Action Fund to support people being displaced and evicted.

Ways to Give

Online Donations

Donations can also be made online at westmarinfund.org/give using a credit card or Stripe.

IRA Charitable Rollover

If you are over 70 1/2 years old, you can directly transfer up to \$100,000 per year from an IRA account to one or more charities. If you are age 72 or older, this transfer counts toward the minimum required distribution rule for IRA accounts. Such distributions are exempt from both income and estate taxes.

Stock Transfer

Publicly traded stocks owned for more than one year may be donated to the West Marin Fund as a charitable gift. Donors are eligible for a tax deduction for the fair market value of the appreciated stock. By donating appreciated stock to the Fund, you can avoid capital gains taxes that would otherwise occur at the sale of the stock.

Financials Fiscal Year 2023-24

Treasurer's Report

West Marin Fund's finances continue to be in good shape with expenditures well under control and assets in solid condition. Investment returns have been positive and in line with market return

The Fund exceeded its fundraising expectations with support from all sources allowing the expansion of grantmaking, program activities and staffing. The Fund is continuing its efforts to broaden its donor base of individual donors, foundations, and government agencies. It is also working towards obtaining, whenever possible, multi-year commitments; this will allow the Fund greater stability when it comes to longer term planning. On the expense side, most items remained well under budget for the entire fiscal year. Expenditure ratios were: Grants 53%, Programs 31%, Administration 8%, and Fundraising 8%.
